






ORDINANCE NO. 2024-198

AN ORDINANCE APPROVING THE 2024 SUPPLEMENTAL BUDGET NO. 3 TO COVER THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT OF MUNTINLUPA IN THE AGGREGATE AMOUNT OF THREE MILLION SEVEN HUNDRED THIRTY-FOUR THOUSAND TWO HUNDRED NINETY-THREE PESOS AND ONE CENTAVO (PHP3,734,293.01) WHICH AMOUNT SHALL BE TAKEN FROM THE 2023 UNEXPENDED BALANCE AS OF APRIL 2024 UNDER THE GENERAL FUND OF THE CITY





WHEREAS, Sections 312 and 319 of the LGC and Article 417 of its implementing Rules and Regulations (LGC-IRR), as amended by Administrative Officer (A.O.) No. 47 series of 1993, "**Allow changes in the Annual Budget of the LGU through a supplement in the Annual Budget under specified circumstances and pursuant to the requirements of the LGC and other applicable laws, rules, and regulations**";

WHEREAS, the Supplemental Annual Investment Program No. 3, CY 2024 duly approved by the Sanggunian Panlungsod through **RESOLUTION NO. 2024-483**, indicated that the Supplemental Budget No.3 amounting to **Three Million Seven hundred Thirty-Four Thousand Two Hundred Ninety-Three Pesos and 01/100 (Php3,734,293.01)**. will be utilized for payment of Prior Years Obligation of the Pamantasan ng Lungsod ng Muntinlupa.

NOW THEREFORE, BE IT ENACTED, by the **10th Sangguniang Panlungsod** in a Session assembled that:

SECTION 1. Short Title. This Ordinance shall be known as approval of Supplemental Budget No, 3, (**SUPBUD3**) **series of 2024**;

SECTION 2. Source of Funds. The source of funds for the SUPBUD 3 series of 2024 in the total amount of **Three Million Seven hundred Thirty-Four Thousand Two Hundred Ninety-Three Pesos and 01/100 (Php3,734,293.01)** shall Be Taken From The Savings (Unexpended Balance) General Fund (Income, Pamantasan ng Lungsod ng Muntinlupa) ;


SECTION 3. Utilization of Appropriated Fund. The funds herein approved shall be released and utilized strictly in accordance with applicable budgeting, accounting, and auditing laws, rules, and regulations.

SECTION 4. Separability Clause - If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION 5. Repealing Clause - all other existing ordinances, executive orders and administrative regulations or part of parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 6. Effectivity – The ordinance shall take effect upon approval.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **13th day of May 2024**, on its **95th Regular Session**.
