THE SUPPLEMENTAL AN ORDINANCE APPROVING BUDGET NO. 4 SERIES OF 2024, IN THE AMOUNT THREE HUNDRED THIRTY-SIX MILLION FOUR HUNDRED NINETY-THOUSAND FIFTY-SEVEN PESOS AND 75/100 SIX WHICH AMOUNT SHALL BE TAKEN (PHp336,496,057,75) FROM THE 2020, 2021, 2022 and 2023 SPECIAL TRUST FUND OF THE DISASTER RISK REDUCTION BALANCE MANAGEMENT (DRRM) FUND

WHEREAS, Article 99, 2(i) of the implementing Rules and Regulations of the LGC, states that the Sanggunian Panlungsod, "Shall approve the annual and supplemental budgets of the City government and appropriate funds for specific programs, projects, services, and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";

WHEREAS, Sections 312 and 319 of the LGC and Article 417 of its implementing Rules and Regulations (LGC-IRR), as amended by Administrative Officer (A.O.) No. 47 series of 1993, "Allow changes in the Annual Budget of the LGU through a supplement in the Annual Budget under specified circumstances and pursuant to the requirements of the LGC and other applicable laws, rules, and regulations";

WHEREAS, the Consolidated Supplemental Annual Investment Program No. 4, CY 2024 duly approved by the Sanggunian Panlungsod through RESOLUTION NO. 2024-484, indicated that the Supplemental Budget No.4 amounting to Three Hundred Thirty-Six Million Four Hundred Ninety-Six Thousand Fifty-Seven Pesos and 75/100 (PHp336,496,057.75) will be utilized for the Disaster Preparedness programs of Various Offices.

NOW THEREFORE, BE IT ENACTED, by the 10th Sangguniang Panlungsod in a Session assembled that:

SECTION 1. Short Title. This Ordinance shall be known as approval of Supplemental Budget No 4, (SUPBUD4) series of 2024;

SECTION 2. Source of Funds. The source of funds for the SUPBUD 4 series of 2024 in the total amount of Thirty-Six Million Four Hundred Ninety-Six Thousand Fifty-Seven Pesos And 75/100 (Php336,496,057.75) shall be taken from the 2020, 2021, 2022 and 2023 Special Trust Fund Balance of the Disaster Risk Reduction Management Fund.

SECTION 3. *Utilization of Appropriated Fund*. The funds herein approved shall be released and utilized strictly in accordance with applicable budgeting, accounting, and auditing laws, rules, and regulations.

SECTION 5. Repealing Clause - all other existing ordinances, executive orders and administrative regulations or part of parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 6. *Effectivity* – The ordinance shall take effect upon approval.
