## ORDINANCE NO. 2024-200

AN ORDINANCE APPROPRIATING THE AMOUNT OF NINE HUNDRED TEN THOUSAND PESOS (PHP910,000.00) OR FIVE THOUSAND PESOS (PHP5,000.00) FINANCIAL ASSISTANCE PER FAMILY WHO WILL BE AFFECTED BY THE SUMMARY EVICTION ALONG PASONG DIABLO AT BARANGAYS ALABANG AND CUPANG, AND IN MAGDAONG WATERWAYS, BARANGAY POBLACION, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM DEPARTMENT OF DISASTER AND RESILIENCE MANAGEMENT (DDRM) FUND

WHEREAS, Section 28 of Republic Act 7279 otherwise known as An Act To Provide For A Comprehensive And Continuing Urban Development And Housing Program, Establish The Mechanism For Its Implementation, And For Other Purposes provides that:

"Eviction and Demolition as a practice shall be discouraged. Eviction or demolition, however, may be allowed under the following situations:

(a) When persons or entities occupy danger areas such as esteros, railroad tracks, garbage dumps, riverbanks, shorelines, waterways, and other public places such as sidewalks, roads, parks, and playgrounds;

(b) When government infrastructure projects with available funding are about to be implemented x-x-x"

WHEREAS, R.A. 7279 likewise provides that in cases relocation cannot be attained or is not possible, a financial assistance in the amount equivalent to the prevailing minimum daily wage multiplied by sixty (60) days shall be extended to the affected families by the local government unit concerned;

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, "The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx";

WHEREAS, pursuant to Section 39 of RA 7279 and its mandate under the Local Government Code, "the City Government of Muntinlupa, through the Urban Poor Affairs Office, endorsed the names of one hundred eighty-two (182) families qualified to be granted financial assistance as they would be affected by the Summary eviction along Pasong Diablo in Barangays Alabang and Cupang, and in Magdaong Waterways in Barangay Poblacion, Muntinlupa City:

WHEREAS, the list of One Hundred Eighty-Two (182) families shall be integral part of this Ordinance;

**WHEREAS,** as certified by the Budget Office there is an available fund from the Department of Disaster Resilience Management (DDRM) Fund;

NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to appropriate the amount of Nine Hundred Ten Thousand Pesos (Php910,000.00) or Five Thousand Pesos (Php5,000.00) Financial Assistance per family who will be affected by the Summary Eviction along Pasong Diablo at Barangays Alabang and Cupang, and in Magdaong Waterways, Barangay Poblacion, Muntinlupa City which amount shall be taken from Department of Disaster and Resilience Management (DDRM) Fund.

ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 13<sup>th</sup> day of May 2024, on its 95<sup>th</sup> Regular Session.
