**AN ORDINANCE GRANTING THE TOTAL AMOUNT OF THIRTY-THREE THOUSAND PESOS (PHP33,000.00) OF FINANCIAL ASSISTANCE TO SIX FAMILIES AFFECTED BY FIRE ON MAY 7, 2024, LOCATED AT NO. 90 ROSAL ST., BERGADO COMPOUND, SUMMITVILLE 3, BARANGAY PUTATAN, MUNTINLUPA CITY**

**WHEREAS**, Section 16 of the Local Government Code of 1991 states that ***“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”***:

**WHEREAS**, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, ***“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”***;

**WHEREAS**, on **May 7, 2024** three (3) structures, housing six (6) family, were gutted by fire at No. 90 Rosal St., Bergado Compound, Summitville 3, Barangay Putatan, Muntinlupa City;

**WHEREAS**, in a final report rendered by the **Social Services Department** on **May 8, 2024**, and received by the **SP Secretariat Office** on **May 13, 2024** the following were noted as casualties of the said fire:

1. **Three (3) structures;**
2. **Six (6) families;**
3. **Twenty-Four (24) individuals;**










**WHEREAS**, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Putatan**, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance amount of **Thirty-Three Thousand Pesos (Php33,000.00)**;

**NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED**, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Thirty-Three Thousand Pesos (Php33,000.00)** of Financial Assistance to **six (6) families** affected by fire on **May 7, 2024**, located at **No. 90 Rosal St., Bergado Compound, Summitville 3, Barangay Putatan, Muntinlupa City**.




