WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, "The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

WHEREAS, on May 8, 2024 one (1) structure housing Two (2) families, were gutted by fire at No. 188 Ilang-Ilang St., Sitio Sto. Niño, Barangay Cupang, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on May 8, 2024, and received by the SP Secretariat Office on May 13, 2024 the following were noted as casualties of the said fire:

- 1. One (1) structures;
- 2. Two (2) families;
- 3. Ten (10) individuals;
- 4. One (1) Child;
- Three (3) Senior Citizens 5.

WHEREAS, the Social Service Department (SSD) of the City of Muntinlupa and the Barangay Chairman of Cupang, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance in the amount of Six Thousand Pesos (Php6,000.00);

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th Sangguniang Panlungsod, to grant the total amount of Six Thousand Pesos (Php6,000.00) of Financial Assistance to two (2) families affected by fire on May 8, 2024, located at No. 188 Ilang-Ilang St., Sitio Sto. Niño, Barangay Cupang, Muntinlupa City.
