**WHEREAS**, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall:

*(i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";*

**WHEREAS**, the Budget Office endorsed and recommended to the Sangguniang Panlungsod the Supplemental Budget No. 1 of Barangay Poblacion amounting to *Five Million Three Hundred Sixty-Seven Thousand One Hundred Fourteen Pesos And 06/100 (Php5,367,114.06)*;

**WHEREAS**, the Supplemental Budget No. 1 is allocated, as follows:

**WHEREAS**, the Supplemental Appropriation Ordinance No. 01, series of 2024, dated March 19, 2024 is recommended **to be declared operative** in its **entirety effective on the date of its approval** subject to the posting requirements under Section 59 of R.A. No. 7160;

**WHEREAS**, the disbursement thereof shall be in accordance with the existing Budgeting, Accounting and auditing rules and regulations as well as the established compensation laws, rules, policies and guidance;

**WHEREAS**, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No. 9184 (Government Procurement Reform Act) and its Revise Implementing Rules and Regulations (IRR) and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan (AIP);

**WHEREAS**, the budget supplemented shall be available exclusively for the specific purposes for which they have been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of Treasury except in pursuance of an Appropriation Ordinance or Law;

**NOW THEREFORE, BE IT ENACTED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to approve the **Supplemental Budget No. 1** for FY 2024 of **Barangay Poblacion**, amounting to **Five Million Three Hundred Sixty-Seven Thousand One Hundred Fourteen Pesos And 06/100 (Php5,367,114.06)** to be taken from the **Surplus Beginning Balance FY 2024 (Unexpended Balance)**.

**ENACTED**, by the 10<sup>th</sup> Sangguniang Panlungsod of **Muntinlupa** this 20<sup>th</sup> day of **May 2024**, on its 96<sup>th</sup> Regular Session.






