WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on **May 10, 2024** two (2) structures housing two (2) **families**, were gutted by fire at **No. 210 Sitio Rizal Fantastic, Barangay Alabang, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on **May 13, 2024**, and received by the **SP Secretariat Office** on **May 20, 2024** the following were noted as casualties of the said fire:

1. **Two (2) structures;**
2. **Two (2) families;**
3. **Four (4) individuals;**




WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Alabang**, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance in the amount of **Eight Thousand Pesos (Php8,000.00)**;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Eight Thousand Pesos (Php8,000.00)** of Financial Assistance to the two (2) families affected by fire on **May 10, 2024** located at **No. 210 Sitio Rizal Fantastic, Barangay Alabang, Muntinlupa City**.


ENACTED FURTHER, that the **Final Disaster Report** dated **May 13, 2024**, of the **Social Services Department (SSD)** shall be charge to the **70% Quick Response Fund (QRF)** from the **Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2024-020** shall form part of this ordinance.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **27th day of May 2024**, on its **97th Regular Session**.


