AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 5, SERIES OF 2024, OF THE GENERAL FUND OF THE CITY GOVERNMENT OF MUNTINLUPA, IN THE AMOUNT OF SEVENTY-TWO MILLION ONE THOUSAND ONE HUNDRED FORTY-FIVE PESOS (PHP 72,001,145.00), FOR THE BUSINESS CAPITAL LOAN PROGRAM FOR MUNTINLUPEÑOS OF MUNTINLUPA ENTREPRENEURSHIP FINANCING DIVISION (MEFD), AND ADDITIONAL SUBSIDY FOR THE OPERATIONS OF OSPITAL NG MUNTINLUPA

WHEREAS, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 (LGC) provides that, **"Every local government shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"**

WHEREAS, Article 99, 2 (i) of the Implementing Rules and Regulations of the Local Government Code, states that the Sanggunian Panlungsod, **"Shall approve the annual and supplemental budgets of the City government and appropriate funds for specific programs, projects, services, and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";**

WHEREAS, Sections 312 and 319 of the Local Government Code and Article 417 of its Implementing Rules and Regulations (LGC-IRR), as amended by Administrative Officer (A.O.) No. 47 series of 1993, **"Allow changes in the Annual Budget of the Local Government Unit through supplement in the Annual Budget under specified circumstances and pursuant to the requirements of the LGC and other applicable laws, rules, and regulations";**





WHEREAS, Supplemental Budget No. 5, Series of 2024, incorporates the appropriations for the Business Capital Loan for Muntinlupeños of Muntinlupa Entrepreneurship Financing Division (MEFD) and additional subsidy for the operations of Ospital ng Muntinlupa;

WHEREAS, the **Supplemental Annual Invest Program No. 5** to support the programs subject of the Supplemental Budget No. 5 was approved by the Sangguniang Panlungsod through **Resolution No. 2024-499**;

NOW THEREFORE, BE IT ENACTED, by the **Sangguniang Panlungsod** in a Session assembled that:

SECTION 1. The Supplemental Budget No. 5, Series of 2024 of the City Government of Muntinlupa for FY 2024 in the total amount of **Seventy-Two Million One Thousand One Hundred Forty-Five Pesos (Php72,001,145.00)**, as approved in the **Supplemental Annual Investment Program** under **Resolution No. 2024-499**, is hereby approved.


SECTION 6. Effectivity – The ordinance shall take effect upon approval.


