AN ORDINANCE DECLARING THE MONTH OF JUNE OF EVERY YEAR AS "INFORMATION AND COMMUNICATIONS TECHNOLOGY MONTH" IN THE CITY OF MUNTINLUPA

WHEREAS, the Department of Information and Communications Technology (DICT) was established under Republic Act No. 10844, which mandates the *promotion, development, and regulation of ICT to ensure universal access to quality, affordable, reliable, and secure ICT services;*

WHEREAS, Proclamation No. 1521 s. 2008 proclaimed the month of June 2008, and every year thereafter, as "*National Information and Communications Technology (ICT) Month*". Further, it called upon all heads of departments, bureaus, offices, agencies and instrumentalities of the national government, including officials of the local governments, to *coordinate with the lead agency (DICT) to implement the plans, programs, and activities geared toward the objectives of the Proclamation;*

WHEREAS, the City of Muntinlupa recognizes the transformative impact of ICT in fostering economic development, improving service delivery and governance, and enhancing the educational and social welfare of its citizens;

WHEREAS, it is essential to align local development initiatives with the national government's direction to *harness the full potential of digital technologies for inclusive growth and sustainable development;*

WHEREAS, acknowledging ICT Month on a local level will *encourage participation from local businesses, schools, community organizations, and government units, fostering an environment conducive to digital learning and innovation;*









WHEREAS, celebrating ICT Month in June aligns with national efforts and showcases the City of Muntinlupa's *commitment to being a forward-thinking, digitally empowered community*;

WHEREAS, it is crucial to engage the public through various programs, workshops, seminars, and activities intended to *promote digital literacy, online safety, and the responsible use of technology during ICT Month*.

WHEREAS, the *declaration of Information and Communications Technology (ICT) Month* promotes technology, data driven policy, and decision making under *Kaunlaran* of the **7K Agenda** of administration of **Mayor Rozzano Rufino B. Biazon**.;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **10th Sangguniang Panlungsod of Muntinlupa** in Session assembled that:

SECTION 1. The City Government of Muntinlupa hereby declares, the month of June of every year as **"Information and Communications Technology (ICT) Month in the City of Muntinlupa."**

SECTION 2. All public and private schools, all local and national government employees and all Barangays within the jurisdiction of Muntinlupa are hereby mandated to join in the celebration of **Information and Communications Technology (ICT) Month** through the conduct of meaningful activities such as, but not limited to:

- 1) **Digital Literacy Workshops for all age groups;**
- 2) **Cybersecurity Awareness Campaigns;**
- 3) **ICT Innovation Fairs showcasing local startups and technologies;**
- 4) **Seminars on the ethical use of technology;**
- 5) **ICT career orientation sessions for students; and**
- 6) **Competitions on software development and digital content creation.**

SECTION 3. Leadership and Coordination. The celebration of **Information and Communications Technology Month** shall be led by the **Management Information Systems Office (MISO)** with the support of the **Public Information Office (PIO)**. They will be responsible for planning, coordinating, and implementing all activities related to the celebration.





SECTION 4. Budget Allocation. The necessary funds for executing the activities shall be sourced from the Annual Budget of the **Management Information Systems Office (MISO)**.

The said office is tasked with, including a specific budget allocation for this purpose in their Annual Budget proposal to ensure the successful execution of the month-long celebration.

SECTION 5. Separability Clause. If any portion of this Ordinance is declared invalid, the remainder shall not be affected and shall remain valid and enforceable.


SECTION 6. Repealing Clause. All ordinances, rules, and regulations, or part thereof, where provisions are in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.


SECTION. Publication. This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the Public Information Office (PIO) in the Official Website of the City Government of Muntinlupa and in all available social media platforms.


SECTION 7. Effectivity. This Ordinance shall take effect after publication.
