**WHEREAS**, on November 12, 2019 the Sangguniang Panlungsod enacted Ordinance 19-028, also known as An Ordinance Creating The Ospital Ng Muntinlupa As A Local Economic Enterprise (LEE), bestowing upon the institution the status as Local Economic Enterprise (LEE);

**WHEREAS**, The Local Finance Council (LFC) adopted on 22<sup>nd</sup> April Resolution No. 07 series of 2024 entitled **A resolution endorsing to the Sangguniang Panlungsod the reversion to the City Government the management and Operation of Ospital ng Muntinlupa (OsMUN) and the consequential Modification/Revocation of City Ordinance No. 19-028,**

**WHEREAS**, the City Council on May 27, 2024 adopted **Resolution No. 2024-248 approving the LFC's recommendation on the reversion to the City Government the management and operation of the OsMun through Closure as exit strategy provided by Local Budget Circular 111 or the Manual On The Setting Up And Operation Of Local Economic Enterprises (LEEs) of the Department of Budget and Management;**

**NOW THEREFORE, BE IT ENACTED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, in Regular Session assembled, **THAT:**

**SECTION 1. Express Repeal.** Ordinance 19-028 also known as Ordinance Creating the Ospital Ng Muntinlupa as a Local Economic Enterprise (LEE) to be called as the **Ospital Ng Muntinlupa Medical Center** is hereby repealed;

**SECTION 2. Transition Period.** There shall be a transition period beginning from the passage of this ordinance until the end of the current fiscal year or until 31 December 2024;

**SECTION 3. Creation of a Technical Working Group (TWG).** During the transition period, a TWG shall be constituted to handle and manage such transition at the Ospital ng Muntinlupa from Local Economic Enterprise (LEE) to becoming a regular office/department of the City Government of Muntinlupa.

**SECTION 4. Authority to Take Over Certain Functions.** The City Mayor is authorized to designate from among the members of the created TWG and/or concerned City Government Offices/department to assume and absorb certain OsMun functions when necessary.

**SECTION 4. Effectivity.** This ordinance shall be in full force and effect beginning on January 1, 2025 or at the start of the new fiscal year.

**ADOPTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **3<sup>rd</sup> day of June, 2024**, on its **98<sup>th</sup> Regular Session**.
