WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *June 2, 2024* one (1) structure housing one (1) family, was gutted by fire at **KM23 West Kabulusan, Barangay Cupang, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on *June 2, 2024*, and received by the **SP Secretariat Office** on *June 6, 2024* the following were noted as casualties of the said fire:


1. *One (1) structure;*

4. *One (1) injured;*






WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Cupang**, conducted a survey on the victims of the fire to determine the casualties basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance in the amount of **Five Thousand Pesos (Php5,000.00)**;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of Five Thousand Pesos (Php5,000.00) of Financial Assistance to the one (1) family affected by fire on June 2, 2024, located at **KM. 23 West Kabulusan, Barangay Cupang, Muntinlupa City**.



ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **10th day of June 2024**, on its **99th Regular Session**.


