AN ORDINANCE GRANTING THE TOTAL AMOUNT OF THREE HUNDRED SIXTY-NINE THOUSAND PESOS (PHP369,000.00) OF FINANCIAL ASSISTANCE TO THE FORTY-SIX (46) FAMILIES AFFECTED BY FIRE ON JULY 8, 2024, LOCATED AT BLOCK 13-17 SAN LORENZO ST., BIAZON ROAD 1, BARANGAY POBLACION, MUNTINLUPA CITY


WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *July 8, 2024* thirty-seven (37) structure housing forty-six (46) families, were gutted by fire at *Block 13-17 San Lorenzo St., Biazon Road 1, Barangay Poblacion, Muntinlupa City*;

WHEREAS, in a final report rendered by the **Social Services Department** on *July 9, 2024*, and received by the **SP Secretariat Office** on *July 11, 2024* the following were noted as casualties of the said fire:

1. *Thirty-Seven (37) structures;*
2. *Forty-Six (46) families;*
3. *One Hundred Ninety-Nine (199) individuals;*
4. *Fifteen (15) Children (0-5 years old);*






WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Poblacion**, conducted a survey on the victims of the fire to determine the casualties basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance in the amount of **Three Hundred Sixty-Nine Thousand Pesos (Php369,000.00)**;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Three Hundred Sixty-Nine Thousand Pesos (Php369,000.00)** of Financial Assistance to the Forty-Six (46) families affected by fire on **July 8, 2024**, located at **Block 13-17 San Lorenzo St., Biazon Road 1, Barangay Poblacion, Muntinlupa City**.


ENACTED FURTHER, that the **Disaster Report** dated **July 9, 2024**, of the **Social Services Department (SSD)** shall be charge to the **70% Quick Response Fund (QRF)** from the **Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2024-028** shall form part of this ordinance.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **15th day of July 2024**, on its **104th Regular Session**.
