A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ROZZANO RUFINO B. BIAZON TO REPRESENT MUNTINLUPA IN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) REPRESENTED BY UNDERSECRETARY RAFAELITA M. ALDABA, PH.D. AND DTI-NATIONAL CAPITAL REGIONAL DIRECTOR MA. SOFIA T. NARAG, ON THE IMPLEMENTATION OF DTI'S LUNSOD LUNSAD PROGRAM UNDER WHICH THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) IS GRANTED TO SUPPORT THE MUNTINLUPA COMMUNITY FURNITURE MAKING WORKSHOP

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

WHEREAS, Republic Act 11904, also known as the **Philippine Creative Industries Development Act**, establishes a favorable policy and governance framework for enhancing the global competitiveness of the Philippine creative industries. Pursuant thereto the Department of Trade and Industry operationalized three (3) key projects that nurture the creativity and innovation of Filipinos namely: FiestaKucha Philippine Regional Creative Festivals, **Lunsod Lunsad** and Philippine Creative Industries Month 2023 Celebration;

WHEREAS, the **Lunsod Lunsad: A Call for Creative Proposals** is a program that aims to identify and support innovative project proposals from Philippine cities, with a focus on maximizing their creative resources for economic and cultural development. The initiative offers funding of up to Three Million Pesos (Php3,000,000.00), with the intention of inspiring a widespread increase in creative projects and stimulating innovation throughout the Philippines;

WHEREAS, the City Government of Muntinlupa has identified the Community Furniture Making Workshop for Muntinlupeno furniture makers as its innovative project proposal to the DTI's Lunsod Lunsad;

WHEREAS, the DTI obligates itself to grant the City Government of Muntinlupa the amount of **One Million Five Hundred Thousand Pesos (Php1,500,000.00)** to subsidize the furniture workshop with the end view of empowering participants, composed of local residents, solo parents and out-of-school youth with woodworking skills thereby fostering economic sustainability, promoting employability, and contributing to the preservation of local heritage;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon** to represent Muntinlupa in a **Memorandum of Agreement (MOA)** with the Department of Trade and Industry (DTI) represented by **Undersecretary Rafaelita M. Aldaba, Ph.D.** and DTI-National Capital Regional Director **Ma. Sofia T. Narag**, on the implementation of DTI's Lunsod Lunsad Program under which the amount of **One Million Five Hundred Thousand Pesos (Php1,500,000.00)** is granted to support the **Muntinlupa Community Furniture Making Workshop**.

ADOPTED, by the **10 Sangguniang Panlungsod of Muntinlupa** this 18th day of **December 2023**, on its **75th Regular Session**.


