WHEREAS, Section 106 of Republic Act 7160 states that, each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian;

WHEREAS, the Comprehensive Development Plan (CDP) is a mediumterm sectoral plan of the local government. For the period of six (6) years, the CDP covers five development sectors: physical (or environmental), institutional, economic, social and infrastructure.

WHEREAS, to aid the LGUs in the formulation of the CDP, various issuances by the Department of Interior and Local Government (DILG) namely: DILG-MC No. 2008-156 dated 22 October 2008 provided for the, "Guide to CDP Preparation for Local Government Unit and further by the published document "Local Planning Illustrative Guide: Preparing and Updating the CDP"; MC No. 2021-037, dated March 31, 2021 with subject, "Updated Guidelines on the Assessment of CDPs of Cities and Municipalities, emphasizing the need to integrate DRR-CCA in the plans and MC No. 2015-77 dated July 21, 2015 with subject, "Guidelines on Mainstreaming Climate Change Adaption and Disaster Risk Reduction in Local Development Planning" and further strengthened by the published document "Guidelines for Mainstreaming DRR and CCA in the CDP (CDP+);

WHEREAS, the DILG and National Economic and Development Authority (NEDA) issued Joint Memorandum Circular No 01 Series of 2018 for the Guidelines on the Localization of the Philippine Development Plan (PDP) 2017-2022 Result Matrices and the Sustainable Development Goals (SDGs) which is aimed, among others to encourage LGUs to identify and implement PPAs that will contribute to the achievement of targets of PDP priority sectors and areas;

WHEREAS, under DILG and NEDA Joint Memorandum Circular No 01 Series of 2018, the mandated formulation of the Result Matrices (RMs) by the LGUs and its adoption by the local Sanggunian shall be the basis for planning in the region;

WHEREAS, in compliance thereto, the City Government of Muntinlupa, held consultation meetings with stakeholders and formulated an updated CDP Plus (CDP +) which is aligned with the higher (international commitments, SDGs, PDP, RDP, etc) and local plans (Local Chief Executive's 7K agenda, MECCAP, DRRM Plan, DTP, CLUP and its update, etc), main streamed (DRR, CCA, GAD etc.) and that the Local Result Matrix (LRM) is integrated:

WHEREAS, the Local Development Investment Program (LDIP) 2023-2026 being the implementing instrument of the CDP, was likewise formulated through stakeholders' ranking of the PPAs listed in the CDP which consist of either new projects, regular programs that are deemed investible or expansion/continuation of funding for existing projects. The 3-year LDIP is sliced into the Annual Investment Programs towards inclusion in the Annual Budget;

WHEREAS, on 21st day November, 2023 the City Development Council of Muntinlupa adopted Resolution No. 02 Series of 2023 or a Resolution Adopting the City of Muntinlupa Comprehensive Development Plan+ (CDP+) 2023-2029, and its accompanying Local Development Investment Program (LDIP) 2023-2026 and Local Result Matrix (LRM), endorsing the same to the Sangguniang Panlungsod

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to approve the Muntinlupa Comprehensive Development Plan + (CDP+) 2023-2029, the Local Development Investment Program (LDIP) 2023-2026 and the Local Result Matrix (LRM).
