WHEREAS, Section 25 or Republic Act 7160, also known as the Local Government Code (LGC) of 1991 provides that, "National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects

WHEREAS, Article 86 of the Rules and Regulations implementing the LGC of 1991 , provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, Republic Act 8792 otherwise known as the Electronic Commerce Act, provides that an electronic online network facilitates the open, speedy, and efficient electronic online transmission, conveyance, and use of electronic documents amongst all government departments, agencies, bureaus, offices, up to the division level, and to the regional and provincial offices, government-owned and controlled corporations, local government units, other public instrumentalities, universities, colleges and other schools and universal access to the general public;

WHEREAS, on April 11, 2023, the Sanggunian enacted Resolution 2023- 228 where the City Council authorized the Mayor Rozanno Rufino B. Biazon to sign a similar agreement for Interconnectivity of Muntinlupa Traffic Apprehension Database to LTO's Information Technology (LTO-IT) Project;

WHEREAS, the present Memorandum of Agreement (MOA) contemplates the interconnection of the City Government's traffic apprehension database and Traffic Apprehension Project with LTO's Information Technology Project (LTO IT Project) on motor vehicle and driver's license database, and create an alarm in the Motor Vehicle Registration System and/or Driver's Licensing System of the LTO IT Project, through the CGM's Law Enforcement and Traffic Adjudication System to ensure the effective implementation of its mandated functions and efficient revenue collection;

WHEREAS, the interconnectivity will entail collection, processing and sharing of Information as follows:
