**WHEREAS**, the Sangguniang Panlungsod of Muntinlupa enacted **Ordinance No. 01-27** as amended by **Ordinance No. 02-77**, otherwise known as Accreditation of Terminals within the City;

**WHEREAS**, aforesaid Ordinances prescribe the physical/infrastructure standard/s and requirements in order that an applicant Transport Terminal be accredited by the City Government;

**WHEREAS**, it is also mandated that accreditation of transport terminals should conform to: *“Ang terminal na nasa loob ng pribadong gusali gaya ng mall o kauri nito na nagpapahimpil ng mga pampublikong sasakyan gaya ng bus, taksi, dyip, FX/Van, atbp., sa loob ng kanilang nasasakupang lugar ay kinakailangang may pahintulot “Memorandum of Agreement” mula sa pamahalaang lungsod upang maging lehitimo ang operasyon ng mga ito.”*;

**WHEREAS**, on **April 11, 2024**, in a letter addressed to the **City Mayor Hon. Rozanno Rufino B. Biazon**, the mall Operations Head of **Manuela Corporation**, requested for the accreditation of **Vista Terminal Exchange (VTX) Alabang**, located at **Metropolis Star, Barangay Alabang, Muntinlupa City**;

**WHEREAS**, the VTX is a modern terminal which will cater passengers to and from the following routes:

- **Ayala, Makati, Alabang, Lawton, Calamba,**
- **Pasay, Bicutan, Zapote, Baclaran, Cubao, and GMA;**
- **Batangas, Bicol, Laguna;**

Using efficient and modernized mode of public transports;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to grant accreditation to **Vista Terminal Exchange (VTX) Alabang**, located at **Metropolis Star, Barangay Alabang, Muntinlupa City** as **Private Terminal of Public Utility Jeepneys (PUJs), Public Utility Buses (PUBs), Van and Modernized E-Jeeps and Taxis**.

**RESOLVED FURTHER**, that the term of this Accreditation is for the period of **Three (3) years** from the approval of this **Resolution**.

**RESOLVED FINALLY**, that the Business Permits and Licensing Office (BPLO), the implementing department tasked to monitor the **compliance** of accredited terminals, shall submit a report on the state of compliance of **VTX**.

**ADOPTED**, by the 10<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 22<sup>nd</sup> day of **April 2024**, on its 92<sup>nd</sup> Regular Session.
