**WHEREAS, he also served as Municipal Administrator and Municipal Attorney** during the time of **Mayor Ignacio "Toting" R. Bunye** from **1988 to 1998**;

**WHEREAS, in his private capacity and together with his loving wife, Dra. Elvira B. Aguinaldo, they donated a piece of property in Barangay Buli for the establishment of a Day Care Center in the said barangay;**

**WHEREAS, as member of the Philippine Bar under Roll of Attorney Number 24673, he was not only a distinguished legal practitioner in Muntinlupa but also he was able to enrich jurisprudence by successfully getting a favorable decision from the Supreme Court which allowed Persons Deprived of Liberty at the New Bilibid Prisons in Muntinlupa to exercise their right of suffrage under our Constitution;**

**WHEREAS, as a distinguished lawyer and public servant, he was able to extend legal assistance and help to countless of his fellow Muntinlupenos, thereby making us all proud of his legacy of public service that is worthy of emulation by our fellow Muntinlupenos;**
