

WHEREAS, Section 20, Article 2 of the 1987 Constitution states that, "The State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments";

WHEREAS, Section 35 of R.A. 7160, otherwise known as the Local Government Code of 1991, encourages the active participation of the private sector in local governance, in the delivery of basic services such as health and nutrition to ensure the viability of local autonomy as an alternative strategy for sustainable development;

WHEREAS, Save the Children Philippines (SCP) Inc., a nonstock, non-profit organization, with which the City Government of Muntinlupa have had a number of collaborations, offers the implementation of its Scale Up IMPACT (*Improved Immunization Coverage with People's Acceptance through Communication and Technology*) Project aimed to sustain and strengthen immunization and other health interventions pursuant to Republic Act 10152 or the Mandatory Infants and Children Health Immunization Act of 2011;

WHEREAS, SCP, Inc.' Scale Up IMPACT Project, funded by the Department of Foreign Affairs and Trade of Australia, aims to address routine and COVID-19 immunization challenges though coordinating and supporting health promotion and public advocacy of immunization programs at the local level;
