WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, ***“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”***;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, ***“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”***;

WHEREAS, with the City Government of Muntinlupa’s 7K agenda and the provision of Fast, Responsive, Efficient and Effective (FREE) service, departments are encouraged that programs being offered by the City should be operationalized by these ideals through the use of technology;









Documents and process patients qualified for the said program. To facilitate the Philhealth claims for this package, an accredited third party electronic provider is imperative;

WHEREAS, BizBox is a Philhealth accredited Health Information Technology Provider (HITP) and eClaims certified on Case Rate System that offers its Cloud-Based system called, BIZBOX Electronic Claims Portal, which enables facilitates to process their Philhealth Claims online;

WHEREAS, For its positive provision of service and fair pricing, Bizbox technology is also being utilized in other health facilities including the Ospital ng Muntinlupa;

WHEREAS, for a minimal amount per successful PhilHealth e-claim made, the City, in the period of two (2) years, will be able to utilize Bizbox E-claims module designed to streamline patient treatment processes, improve record-keeping, and ensure compliance with health standards;

WHEREAS, the City Legal Office finds no legal hindrance to the execution of the MOA provided that provisions of the same be within the requirements of Philhealth, the Data Privacy Law and budgetary policies;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to enter into and sign the Memorandum of Agreement (MOA) with BizBox, Inc., represented by Bobby Lua, Chief Executive Officer, and Randy T. Soria, authorized representative, on the installation and use of the Electronic Claims Portal for the City Health Office Tuberculosis Directly Observed Treatment (TB-DOTS) Philhealth Package.





