





BIAZON TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO REPRESENT THE CITY GOVERNMENT OF MUNTINLUPA WITH LAND BANK OF THE PHILIPPINES, ON THE INSTITUTIONAL ATM PAYROLL FACILITY USING LAND BANK PISO ACCOUNT WITH LAND BANK OF THE PHILIPPINES (LBP) ON THE CREDITING OF ALLOWANCES FROM THE MUNTINLUPA SCHOLARSHIP DIVISION TO STUDENT BENEFICIARIES THROUGH THEIR RESPECTIVE LBP ACCOUNTS.

WHEREAS, Section 455 of Republic Act 7160 of the Local Government Code of 1991, *empowers the city mayor, as chief executive of the city government, to exercise such powers and perform such duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;*

WHEREAS, pursuant to the powers granted under RA 7160, otherwise known as the Local Government Code of 1991, *“The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”;*

WHEREAS, Section 22(c) of the same Code further provide that, *“unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;*





WHEREAS, the Memorandum of Agreement (MOA) on institutional ATM Payroll (or batch credit) Facility using **Land Bank PISO (Pertaining Inimpok Savings Option)** Account between the City Government and the Land Bank of the Philippines;

WHEREAS, beneficiaries shall open a **PISO Account** with Land Bank where the City may deposit or transfer the allowances which shall be credited to the beneficiaries' accounts. The City shall be obliged to maintain on average daily balance in its account;

WHEREAS, the Land Bank assumes no responsibility for the accuracy of the data that City will provide;

WHEREAS, the Land Bank Payroll Accounts is subject to the existing Land Bank policies and guidelines of **Land Bank PISO** deposit account and other applicable terms and conditions;


WHEREAS, payment for the cost of initial **Piso ATM** card issued to each employee/qualified beneficiary shall be free of charge. However, the cost of succeeding card replacements shall be for the account of the cardholder, subject to the prevailing card replacement fee;

WHEREAS, the City Legal Office has no objection to the Memorandum of Agreement (MOA);

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Rozzano Rufino B. Biazon** to enter and sign the **Memorandum of Agreement (MOA)** to represent the City Government of Muntinlupa with **Land Bank of the Philippines**, on the Institutional ATM Payroll Facility using **Land Bank PISO Account** with **Land Bank of the Philippines (LBP)** on the crediting of allowances from the **Muntinlupa Scholarship Division (MSD)** to student beneficiaries through their respective LBP accounts.

ADOPTED, by the 10th **Sangguniang Panlungsod ng Muntinlupa** this 13th day of **May 2024**, on its 95th Regular session.
