WHEREAS, in a letter dated **April 2024**, the City Treasurer requested for an authority from the Sangguniang Panlungsod for the City Government of Muntinlupa for the opening of trust account/s with the Land Bank of the Philippines (LBP)-Muntinlupa City Branch;

WHEREAS, the said request is in line with the Department of Energy [Department] Circular No. 2018-08-0021 entitled, **“Providing for the Amendments to Rule 29 Part (A) of the Implementing Rules and Regulations of Republic Act No. 9136”** which took effect on **August 23, 2018**;

WHEREAS, the City Government of Muntinlupa is required to submit Bank Certificate from LBP indicating the Trust Account/s for Development and Livelihood Fund (DLF) and Reforestation, Watershed Management, Health and/or Livelihood Fund in order to facilitate the direct remittance of ERI-94 funds;

WHEREAS, in order to open a Trust Account under the LBP-Muntinlupa City Branch, there is a need for a resolution issued by the Sangguniang Panlungsod of Muntinlupa authorizing the City Mayor **Hon. Rozanno Rufino B. Biazon** to represent the City in these acts;

ADOPTED, by the 10th Sangguniang Panlungsod ng Muntinlupa this 13th day of **May 2024**, on its **95th Regular Session.**


