









**WHEREAS**, under Section 15, Article II of the Philippines Constitution, *"It is the State's policy to protect and promote the right to health of the people"*;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, *"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*;

**WHEREAS**, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, *"Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants"*;

**WHEREAS**, the City Development Council (CDC) approved Resolution No. 02, Series of 2024, a Resolution adopting the Supplemental Annual Investment Program (AIP) No. 2 its Supplemental Budget for FY 2024 amounting to **Two Hundred Fifty Six Million Eight Hundred Seventy Seven Thousand Three Hundred Sixty Five Pesos And 65/100 (PHp 256,877,365.65)**;



**WHEREAS**, the Bureau of Fire and Protection, the Office for the Senior Affairs and various offices in the City Government of Muntinlupa submitted supplemental programs, projects and activities (PPAs) as well as the monetary requirement for its implementation. The PPAs, indicating the need to fund Capital Outlays and other Maintenance and other Operating Expenses, with its corresponding budget were consolidated into the Supplemental Budget No. 2 indicated as follows:


**WHEREAS**, some of the proposed PPAs were included in the AIP 2024 but need additional funding while other PPAs were not found in the 2024 AIP hence the urgency for a supplemental budget;

**WHEREAS**, two Certifications of unexpended cash balance as of December 31, 2023 in the amount of **Two Hundred Thirty Two Million Thirty Seven Thousand Two Hundred Ninety Four Pesos and 94/100 (Php232,037,294.940)** and **Twenty Four Million Eight Hundred Forty Thousand Seventy Pesos and 71/100 and (PHp24,840.070.71)**, both under the General Fund, were issued by the City Treasurer's Office. Likewise, a Statement of Funding Sources (LBP Form 8) indicating the same amount as emanating from the Savings and 20% Share from the BFP was signed jointly by the City Treasurer and OIC City Accounting Department;

**NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY RESOLVED**, by 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to adopt Council Development Committee (CDC) **Resolution No. 2 S. 2024** otherwise known as, "**adopting the Supplemental Annual Investment Program (AIP) No. 2 and its Supplemental Budget for FY 2024**".

**ADOPTED**, by the 10<sup>th</sup> Sangguniang Panlungsod ng Muntinlupa this 13<sup>th</sup> day of **May 2024**, on its 95<sup>th</sup> Regular Session.
