WHEREAS, under Section 15, Article II of the Philippines Constitution, ***"It is the State's policy to protect and promote the right to health of the people"***;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, ***"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"***;

WHEREAS, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, ***"Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants"***;

WHEREAS, the City Mayor ***Hon. Rozzano Rufino B. Biazon***, endorsed to the Sangguniang Panlungsod the consolidated Supplemental PPAs for Supplemental Budget ***Annual Investment Program (AIP) No. 3 for F.Y. 2024*** for the City of Muntinlupa for the adoption thru a Sanggunian Resolution;



WHEREAS, the Pamantasan ng Lungsod ng Muntinlupa is a Local Economic Enterprise by virtue of Ordinance 19-27. As such, it is assumed to be self-sustaining, discharging its mandate through the use of its own income;

WHEREAS, PLMUN incurred operating expenses and office equipment which have been delivered/completed and accepted, but remained unpaid as of the end of the preceding year in the amount of Php3,734,293.01;


WHEREAS, a Certification of unexpended cash balance as of December 31, 2023 in the amount of Php3,734,293.01 was issued by the City Treasurer's Office. Likewise, a Statement of Funding Sources (LBP Form 8) indicating the same amount as emanating from the Savings (General Fund PLMUN's Income) was signed jointly by the City Treasurer and OIC City Accounting Department;

WHEREAS, the need to adopt the Supplemental AIP No. 3 for FY 2024 is imperative as the PPAs for the objects of supplemental budget were not included in the plan and allocation of funding in the AIP for FY 2024;



ADOPTED, by the **10th Sangguniang Panlungsod ng Muntinlupa** this **13th day of May 2024**, on its **95th Regular Session**.


