**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";**

**WHEREAS**, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, **"Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants";**

**WHEREAS**, on 30<sup>th</sup> April 2024, pursuant to DILG Legal Opinion No. 42, S. 2015, the City Development Council (CDC) adopted **Resolution No. 5 series of 2024** citing the adopted resolutions by the Muntinlupa Local Disaster Risk Reduction Management Council to wit:

- a. LDRRMC Res. No.1 Series of 2024 (February 15, 2024) on the Utilization of the 2022 Special Trust Fund in the amount of Php127,958,687.49;
- b. LDRRMC Res. No.2 Series of 2024 (February 15, 2024) on the Utilization of the 2021 Unexpended balance of the Special Trust Fund in the amount of Php6,250,560.00;
