**WHEREAS**, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";**



**WHEREAS**, by virtue of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **“the delivery of health services and facilities were devolved to the Local Government Units, hence, LGUs are the primary holder of medical records of the constituents who opt to avail of the public health services”**;

**WHEREAS**, the Department of Health, aside from being the principal health agency in the Philippines responsible for ensuring access to basic public health services to all Filipinos, likewise is mandated to be the over-all technical authority in health in three major roles of leadership and regulator in health, enabler and capacity builder, and administrator of special health services;

**WHEREAS**, the public hearing was held for the request for an authority to enter and sign the Memorandum of Understanding (MOU) with Department of Health Center for Health Development, represented by its National Capital Region Director and PHILHEALTH Insurance Corporation Regional Office, represented by its Vice President/Regional Vice President on the implementation of the Local Health System Integration;

**WHEREAS**, through the Memorandum of Understanding (MOU), the City commits to integrate its local health system (all health offices, facilities and services, human resources and other operations relating to health managed by the City) into a **City-Wide Health System** through managerial and financial integration where all health care providers endeavour to deliver continuous and integral health care and where the private sector shall be encouraged to participate.

**WHEREAS**, the Commitment involves, among other, the creation of a Special Health Fund (SHF) to be managed by the City through the Local Health Board sourced from financial grants and subsidies from the national government, income from PhilHealth payments and other sources and the creation of at least two (2) divisions in the City Health Office, to wit: The **Health Service Delivery Division** and **Health System Support Division**, each headed by an **Assistant City Health Officer** as well as a **Health Promotion Unit** and the establishment of a **Local Universal Health Care (UHC) Integration System (IS) Management Team**;

**WHEREAS**, the City Legal Office has no objection to the Memorandum of Understanding (MOU).

**NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to enter into and sign the Memorandum of Understanding (MOU) with **Department of Health Center for Health Development**, represented by its National Capital Region Director and **PHILHEALTH Insurance Corporation Regional Office**, represented by its Vice President/Regional Vice President, on the implementation of the **Local Health System Integration**.
