BIAZON TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE WITH THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) FOR ONE (1) SET RADIO COMMUNICATIONS EQUIPMENT INCLUDING ACCESSORIES AND PERIPHERALS FOR DISASTER PREPAREDNESS AND RESPONSE OF THE CITY

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

WHEREAS, Section 76, Title II of P.D. 1445 on transfer of property between government agencies, provides that, **“Any government property that is no longer serviceable or needed by the agency to which it belongs may be transferred without cost, or at an appraised value, to other agencies of the government upon authority of respective heads of agencies in the national government, or of the governing bodies of government-owned or controlled corporations, other self-governing boards or commissions or the government, or the local legislative bodies for local government units concerned”;**





WHEREAS, the Metropolitan Manila Development (MMDA) is a government agency of the Philippines responsible for constituting the regional government of Metro Manila;

WHEREAS, the MMDA, pursuant to its program for enhancement of Emergency Radio Communication Network within the region, will transfer its radio communications equipment with acquisition year of 2020 to the City Government of Muntinlupa with the end view to provide immediate communication link between the members of the Metro Manila Disaster Risk Reduction and Management Council;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Hon. Mayor Rozzano Rufino B. Biazon** to enter into a **Deed of Donation and Acceptance (DODA)** with the **Metropolitan Manila Development Authority (MMDA)** for one (1) set radio communications equipment including accessories and peripherals for disaster preparedness and response of the City
