WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;**

WHEREAS, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, **“Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants”;**

WHEREAS, Section 21 of RA 10121 or the **Philippine Disaster Risk Reduction and Management Act of 2010, created the Local Disaster Risk Reduction and Management Fund (LDRRMF) which must be based on the Local Disaster Risk Reduction and Management Plan (LDRRMP) as incorporated in the local development plans and annual work and financial plan;**

WHEREAS, supra, **“Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMCs within the next five (5) years. Any such amount still not fully utilized after five (5) years shall revert back to the general fund and will be available for other social services to be identified by the local sanggunian;”**



WHEREAS, on 30th April 2024, the City Development Council (CDC) adopted Resolution No. 5 series of 2024 citing the adopted resolutions by the Muntinlupa Local Disaster Risk Reduction Management Council to wit:


- a. **LDRRMC Res. No.1** Series of 2024 (February 15, 2024) on the Utilization of the 2022 Special Trust Fund in the amount of Php127,958,687.49;
- b. **LDRRMC Res. No. 2** Series of 2024 (February 15, 2024) on the Utilization of the 2021 Unexpended balance of the Special Trust Fund in the amount of Php6,250,560.00;
- c. **LDRRMC Res. No. 3** Series of 2024 (February 15, 2024) on the Utilization of the 2020 Unexpended balance of the Special Trust Fund in the amount of Php44,381,089.89
- d. **LDRRMC Res. No. 4** Series of 2024 (April 18, 2024) on the Utilization of the 2023 Unexpended balance of the Special Trust Fund in the amount of Php 157,905,720.37;

WHEREAS, aforecited unexpended balance of the STF shall now be utilized to fund the **LDRRMFIP** on disaster preparedness, response, recovery and rehabilitation;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to Adopt the **City Development Council (CDC) Resolution No. 4 Series of 2024 or "A Resolution Adopting The Revised Muntinlupa City Local Disaster Risk Reduction And Management Fund Investment Plan (LDRRMFIP) With The Unexpended Balances For Special Trust Fund (STF) Cy 2020, 2021, 2022 And 2023"**.
