**WHEREAS**, Ronaldo Lopez Loresca well-known as "Kap. Kaok" has been in public service for 6 years and his last 6 years were served as Chairman of Barangay Buli, Muntinlupa City;

**WHEREAS**, during his Chairmanship, Kap. Kaok placed Barangay Buli in the map by gracing the prestigious "**Seal of Good Local Governance**" as **National Passer in 2023**, which award was conferred by the **Department of the Interior and Local Government (DILG)**;

**WHEREAS**, on a fateful day of 22 May 2024, at the age of 48, Kap. Kaok was shot dead by unidentified men alongside Manuel L. Quezon Street, Barangay Buli, Muntinlupa City;

**WHEREAS**, after the incident, the City Government of Muntinlupa, in cooperation with **PNP-Muntinlupa**, immediately began the investigation to identify the assailants;

**WHEREAS**, the efforts to serve justice to the bereaved family of Kap. Kaok and his constituents will not surpass the dedication and heartfelt service of this wise and valiant leader;

**WHEREAS**, as we are all saddened at the loss of this good man, whose ideals and accomplishments have been respected, the City Government of Muntinlupa strongly condemns the heinous killing of **Barangay Chairman Ronaldo "Kaok" L. Loresca**;






