





WHEREAS, pursuant to the powers granted under RA 7160, otherwise known as the Local Government Code of 1991, *“The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”;*

WHEREAS, the Philippine National Volunteer Service Coordinating Agency (PNVSC) is a government agency under the National Economic and Development Authority (NEDA) which is mandated to formulate policies and guidelines, organize and implement national volunteer service program and coordinate the activities of local and international volunteer organizations and; to promote volunteerism as a strategy for national development and international cooperation;

Biazon to enter into a Memorandum of Understanding (MOU) with the Philippine National Volunteer Service Coordinating Agency (PNVSCA) represented by Donald James D. Gawe, Executive Director, to confirm the status of the City Government Of Muntinlupa as first Volunteerism Local Learning Hub in the Philippines.
