WHEREAS, Section 455 of Republic Act 7160 of the Local Government Code of 1991, *empowers the city mayor, as chief executive of the city government, to exercise such powers and perform such duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;*

WHEREAS, pursuant to the powers granted under RA 7160, otherwise known as the Local Government Code of 1991, *“The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”;*

WHEREAS, Philippines Veterans Bank (PVB), is a private commercial banking corporation and authorized government depository bank (AGDB) with which the City Government of Muntinlupa maintains several accounts;

WHEREAS, as part of its services, PVB installed Automatic Teller Machines (ATMs) at the Centennial Avenue, Tunasan, catering not only for the employees of the City Health Office and members of the Philippine National Police but also for the general public as well;







