BIAZON TO REPRESENT THE CITY GOVERNMENT OF MUNTINLUPA IN A MEMORANDUM OF UNDERSTANDING WITH DEPARTMENT OF SCIENCE AND TECHNOLOGY INDUSTRIAL TECHNOLOGY DEPARTMENT INSTITUTE (DOST-ITDI) FOR PURPOSES OF ALIGNING THE VERIFICATION PROCESS OF NON AUTOMATIC WEIGHING INSTRUMENT (NAWI) AND FUEL DISPENSER OF THE FORMER WITH ASSOCIATION OF SOUTH EAST ASIAN NATION (ASEAN) STANDARDS

WHEREAS, pursuant to the powers granted under RA 7160, otherwise known as the Local Government Code of 1991, **“The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”;**

WHEREAS, the Philippines, as member of the ASEAN, is bound by the Agreements with which it is a signatory. One of the political commitments of the country is to focus on progress reduction towards elimination of all barriers to regional economic integration;

WHEREAS, Section 5 of Republic Act No. 9236, otherwise known as the **National Metrology Act of 2003**, appointed the **Department of Science and Technology Industrial Technology Department Institute (DOST-ITDI)** as the secretariat of the **National Metrology Board (NMB)** which is mandated among others, to supervise and to assure the execution and calibration of standards and verification equipment;


WHEREAS, the **Metro Manila Development Authority (MMDA)** adopted **Resolution No. 23-07**, Series of 2023 which supports the **Department of Science And Technology (DOST)** projection aligning the Capabilities of Metro Manila's Local Legal Metrology Authorities to the ASEAN Guidelines for **Non Automatic Weighing Instrument (NAWI) and Fuel Dispenser**;

WHEREAS, the City Government of Muntinlupa pursuant to its 7K Agenda, Kaunlaran, undertakes to protect the consumers against the consequences of inaccurate and fraudulent measuring instruments used in trade and elevate the knowledge and skills of legal metrology regulators in the City comparable to international standards through trainings and proficiency testing to be conducted by the DOST-ITDI;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to represent the City Government of Muntinlupa in a **Memorandum of Understanding (MOU)** with **Department of Science and Technology Industrial Technology Department Institute ((DOST-ITDI)** for purposes of aligning the verification process of **Non Automatic Weighing Instrument (NAWI)** and fuel dispenser of the former with **Association of South East Asian Nation (ASEAN) Standards**.
