WHEREAS, Section 455 of Republic Act 7160 of the Local Government Code of 1991, states that, ***“empowers the city mayor, as chief executive of the city government, to exercise such powers and perform such duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants”;***

WHEREAS, pursuant to the powers granted under RA 7160, otherwise known as the Local Government Code of 1991, ***“The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”;***

WHEREAS, Land Bank of the Philippines (LBP) is a government financial institution and an authorized government depository bank (AGDB) with which the City Government of Muntinlupa (CGM) maintains several accounts;

WHEREAS, the City Government of Muntinlupa, in addition to the accounts being maintained with the LBP, desires to avail of the latter’s ATM Payroll facility for the CGM’s personnel regardless of appointment status;
