WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, the New Veterinary Code of Muntinlupa, as amended, provides that "All local residents or corporate entities residing in the territorial jurisdiction of Muntinlupa City who are pet owners and possessors of animals categorically related and/or scientifically classified to the following: canine (dogs and feline (cats) upon reaching three (3) months-of-age and older, must be vaccinated against Rabies and registered once a year and every year thereafter at the Office of the City Veterinarian (O.C.V.)";

WHEREAS, the registration of animals referred above is implemented through microchipping, where the Two Hundred and Fifty Pesos (PHp250.00) fee/cost is bourne by the owner;

WHEREAS, *Birdentity Phil. Inc,* known herein as **Petdentity**, offered its Pet Microchip technology with mobile and web application to support concrete data gathering and control rabies in animals in the City of Muntinlupa;

WHEREAS, the City Legal Office opined that pet microchipping is not mandatory and on a voluntary basis on the part of the pet owner hence microchips implanted will not be within the ambit of procurement processes and policies;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa to authorize the Hon. City Mayor Rozzano Rufino B. Biazon, to enter into and sign the Memorandum Of Agreement (MOA) with Petdentity Philippines, Inc., for the Office Of The City Veterinary's (OCV) Unified Pet Data Management through the use of microchip in pet registration.
