BIAZON TO REPRESENT THE CITY OF MUNTINLUPA IN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) ON THE GRANT OF HEALTH EMERGENCY ALLOWANCE (HEA) TO ELIGIBLE HEALTH CARE WORKER (HCW) AND NON-HEALTH CARE WORKER (non -HCW) OF THE OSPITAL NG MUNTINLUPA (OSMun)

WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod";

WHEREAS, Republic Act 11712 known as the Public Health Emergency Benefits and Allowances for Health Care Workers Act and its Implementing Rules and Regulations (IRR) provides for the payment of Health Emergency Allowance (HEA), Sickness, and Death Compensation and other Benefits for public and private health care workers (HCWs) and non- HCWs during the Covid-19 pandemic and other future public health emergencies with retroactive applications starting July 1, 2021;

WHEREAS, Section 5 of the same act stipulates that the amount of HEA shall vary based on the risk exposure categorization. The Risk exposure categorization was amplified and classified through DOH Administrative Order No. 2022-0001-A;

WHEREAS, the national government, through Republic Acts (RA) 11936 (General Appropriations Act (GAA) FY 2023 and RA No. 11975 or GAA FY 2024, has appropriated funds for the payment of arrears to the eligible HCWs and non-HCWs pursuant to RA 11712;

WHEREAS, the eligible HCWs and non-HCWs of the Ospital ng Muntinlupa shall be the recipient of the total amount of ONE HUNDREDTWENTY-NINE MILLION TWO HUNDRED NINETY-SEVEN THOUSAND ONE HUNDRED FIFTY-SIX PESOS AND 25\100 ONLY (PhP129,297,156.25) upon submission of the complete documentary requirements and subject to pertinent accounting rules and regulations. The funds are computed as follows:
