



RESOLUTION 2024-517

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH RGDG CONSTRUCTION, FOR THE PROJECT CONSTRUCTION OF PERIMETER FENCE & STEEL GATE AT TIOSEJO MULTI-PURPOSE LOCATED BARANGAY TUNASAN, MUNTILUPA CITY IN THE AMOUNT OF TWO MILLION NINE HUNDRED EIGHTY-FIVE THOUSAND THREE HUNDRED SIXTY-FIVE PESOS (PHP2,985,365.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2024 SUPPLEMENTAL BUDGET NO. 1 UNDER INFRA FUNDS










WHEREAS, Section 7, supra, provides, “All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity. Consistent with government fiscal discipline measures, only those considered crucial to the efficient discharge of governmental functions shall be included in the Annual Procurement Plan (APP)”;

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, “The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”;

WHEREAS, the City Government of Muntinlupa, in its approved APP, listed the project/s: **construction of Perimeter Fence & Steel Gate located at Tiosejo Multi-Purpose, Barangay Tunasan, Muntinlupa City**;

WHEREAS, the duly constituted Bids and Awards Committee (BAC) of Muntinlupa, acting on its mandate, advertised the invitation to apply for eligibility and to bid for the project: **construction of Perimeter Fence & Steel Gate located at Tiosejo Multi-Purpose, Barangay Tunasan, Muntinlupa City**. To comply with the provisions of Procurement Act and its IRR, and R.A. 8792, otherwise known as the “Electronic Commerce Act, the same project was likewise posted continuously for seven (7) days at the *Philippine Government Electronic Procurement System (PhilGEPS)*, City’s website and conspicuous places within the premises of the City Government of Muntinlupa;

WHEREAS, in response to the said advertisement/s and publication/s, two (2) bidders submitted their letters of intent and applications for eligibility:

WHEREAS, on **May 28, 2024**, **RGDG Construction**, submitted its bid documents. In the Preliminary Examination of Bid conducted at the City Administrator’s Conference Room, 2nd Floor City Hall Main Building, it was determined that the required bid documents are present and may be considered for opening and evaluation of their financial component;





WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements, **RGDG Construction**, bid was adjudged to be responsive to the **Approved Budget for the Contract (ABC)** amounting to **Php2,993,365.27**. Thereafter, the project was awarded to **RGDG Construction**, as the Highest Responsive bidder for the project **construction of Perimeter Fence & Steel Gate located at Tiosejo Multi-Purpose, Barangay Tunasan, Muntinlupa City;**


NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the City Mayor Hon. **Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a **RGDG Construction**, for the project **construction of Perimeter Fence & Steel Gate located at Tiosejo Multi-Purpose, Barangay Tunasan, Muntinlupa City** in the amount of **Two Million Nine Hundred Eighty-Five Thousand Three Hundred Sixty-Five Pesos (Php2,985,365.00)** which amount shall be taken from the **2024 Supplemental Budget No. 1**, under **Infra Funds**.
