**AN ORDINANCE GRANTING THE TOTAL AMOUNT OF TWENTY-FOUR THOUSAND PESOS (PHP24,000.00) OF FINANCIAL ASSISTANCE TO FIVE (5) FAMILIES AFFECTED BY FIRE ON AUGUST 23, 2024, LOCATED AT PHASE 2 BLOCK 35 LOT 5-7 & 48, BARANGAY POBLACION, MUNTINLUPA CITY**

**WHEREAS**, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

**WHEREAS**, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

**WHEREAS**, on **August 23, 2024** four (4) structures housing five (5) families, were gutted by fire at **Phase 2 Block 35 Lot 5-7 & 48, Barangay Poblacion, Muntinlupa City**;

**WHEREAS**, in a report rendered by the **Social Services Department** on **August 27, 2024** and received by the **SP Secretariat Office** on **August 27, 2024** the following were noted as casualties of the said fire:

1. **Four (4) structures;**
2. **Five (5) families;**
3. **Twenty-Eight (28) individuals with the following details:**
  - a. **Three (3) ages 0-5 years old;**
  - b. **One (1) Lactating Mother**









**WHEREAS**, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Poblacion**, conducted a survey on the victims of the fire to determine the casualties basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance in the amount of **Twenty-Four Thousand Pesos (Php24,000.00)**;

**NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED**, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Twenty-Four Thousand Pesos (Php24,000.00)** of Financial Assistance to the **Five (5)** families affected by fire on **August 23, 2024**, located at **Phase 2 Block 35 Lot 5-7 & 48, Barangay Poblacion, Muntinlupa City**.

**ENACTED FURTHER**, that the **Disaster Report** dated **August 27, 2024**, of the **Social Services Department (SSD)** shall be charge to the **30% Quick Response Fund (QRF)** from the **Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2024-034** shall form part of this ordinance.

**ENACTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **3<sup>RD</sup>** day of **September, 2024**, on its **111<sup>th</sup> Regular Session**.


