





WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, part of the centerpiece of the City Government of Muntinlupa(CGM) is Karunungan where the **“mataas na kalidad ng edukasyon”** is being supported and championed by the administration;

WHEREAS, pursuant to the 7K agenda, the Executive Department, is to enter into an Internship Agreement with **Ms. May Tirona**, a resident of Muntinlupa who is a Tourism student at **Eulogio Amang Rodriguez Institute of Science and Technology (EARIST);**




