**WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

**WHEREAS, Section 455 (b)(1)(vi) of the LGC states that "The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance";**

**WHEREAS, Article II, Section 4(d) and (e) of R.A. No. 7926, also known as the Charter of the City of Muntinlupa (Charter), empowers the City, as a political body corporate, xxx and to enter into contracts";**

**WHEREAS, the Philippine Electrical Code and the National Building Code of the Philippines provides for the safeguarding of persons and buildings from various hazards that may arise from the use of electricity and served as guide posts for the issuance of policies for the implementation of the same;**

**WHEREAS**, the Manila Electric Company (MERALCO), is a grantee of franchise under Republic Act 9209 or An Act Granting The Manila Electric Company A Franchise to Construct, Operate and Maintain a Distribution System for the Conveyance of Electric Power to the End-Users In the **Cities/Municipalities Of Metro Manila**, Bulacan, Cavite and Rizal, and Certain Cities/Municipalities/Barangays In Batangas, Laguna, Quezon and Pampanga;

**WHEREAS**, MERALCO under the provision of its franchise, shall supply electricity to its captive market in the least cost manner and as far as shall modify, improve or change its facilities, poles, lines, systems and equipment for the purpose of providing efficient and reliable service and reduced electricity costs. Pursuant thereto, MERALCO, as a requirement for electrification, oblige the applicant a **Certificate of Final Electrical Inspection (CEEI)** and **Temporary Service Connection** issued by the local government units;


**WHEREAS**, to streamline and expedite the procedure of electrical, prevent the submission of fake or fraudulent CEEIs and to ensure that electrical wirings are compliant with the provisions of the law, MERALCO recommended an electronic submission of exclusive list of all approved CEEIs and Temporary Service Connection, electronically signed by the building official;

**WHEREAS**, the City Legal Office, as compliance with the Data Privacy Law, requires MERALCO to register its data processing system with the National Privacy Commission and a Data Sharing Agreement be executed for the personal and sensitive information contained in the CEEIs and Temporary Permit;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon** to enter into a Memorandum Of Agreement (MOA) with Manila Electric Company (MERALCO) for the Electronic Sharing of approved **Certificate of Final Electrical Inspection (CEEI)** and Temporary Service Connection.

**ADOPTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **22<sup>nd</sup>** day of **July, 2024**, on its **105<sup>th</sup> Regular Session**.
