**WHEREAS**, Section 16 of Republic Act 7160 or the Local Government Code of 1991, provides that, **“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

**WHEREAS**, Section 22(c), Supra, further provide that, **“unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned;**

**WHEREAS**, the Local Government Code *encourages the participation of the private sector in local governance. This is echoed in R.A. 7277, where is declared a policy of the state to encourage partnership with the private sector in programs that address the needs and concerns of disabled persons;*

**WHEREAS**, Republic Act 10070, also known as An Act Establishing Institutional Mechanism To Ensure The Implementation Of Programs And Services For Persons With Disabilities In Every Province, City And Municipality, provides that Persons with Disability Affairs Office (PDAO) may seek donations in cash or in kind from local or foreign donors to donors to implement an approved work plan for PWDs in accordance with existing laws and regulations as well as to monitor fund-raising activities being conducted for the benefit of Persons with Disability (PWD);









**WHEREAS**, the City Government of Muntinlupa and the Bellevue Manila is desirous to enter into a Memorandum of Agreement (MOA) to facilitate the implementation of AGAP (Agarang Gabay at Alalay Pambata), a program of Muntinlupa Persons with Disability Affairs Office (PDAO) for the benefit of children with disabilities;

**WHEREAS**, under the Memorandum of Agreement (MOA), Bellevue Manila shall grant the use of its **Kids Play Area**, free of charge, to the City as a Consultation Facility for children with disabilities, particularly the Autism, Attention Deficit Hyperactive Disorder (ADHD) and other related conditions within the spectrum on a designated schedule;

**WHEREAS**, under the Memorandum of Agreement, the local government of Muntinlupa shall:

- (1) Implement Ticketing System to ensure that consultation is done one at a time;**
- (2) Ensure that each consultation is limited to a maximum of 8 individuals inclusive of personnel and patients;**
- (3) Manage and monitor the sessions to maintain orderliness with the Kids Play Area;**
- (4) Be responsible for disseminating information regarding proper decorum, dress code and adherence to Bellevue's policies and procedures to all government employees, patients and their guardians.**

**WHEREAS**, the Kids Play Area provided by Bellevue Manila shall likewise be a venue for the assessments and consultation for children with disability;

**WHEREAS**, the MOA shall be effective for a period of one (1) year with the following notable conditions:

- a. Bellevue shall not be held liable for any injuries or accidents that may occur to Muntinlupa City personnel, patients, families, or any LGU employees and officers involved in the consultation;**
- b. CGM agrees to release Bellevue from any legal liabilities pertaining to the children, parents, families, or any LGU employees and officers involved in the consultation;**
- c. the Bellevue Manila shall not be held liable for any COVID infections that may occur to LGU personnel, families or any other individuals within the hotel premises during the consultation session;**

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod**, to authorize the **City Mayor Rozzano Rufino B. Biazon** to enter into a **Memorandum of Agreement (MOA)** with **The Bellevue Manila** on the implementation of project **AGAP (Agarang Gabay At Alalay Pambata)**, through the use of **Kids Play Area**, free of charge, as consultation facility for children with disabilities.
