WHEREAS, Section 27 of the Universal Health Care (UHC) Act or Republic Act (RA) No. 11223 states that, **"The DOH shall institute a licensing and regulatory system for stand-alone health facilities, including those providing ambulatory and primary care services, and other modes of health service provision."**

WHEREAS, the Department of Health (DOH) issued **Administrative Order No. 2020 – 0047** or the Rules and Regulations Governing the Licensure of Primary Care Facilities in the Philippines, detailing among others the need for health facilities to secure a Permit to Construct as a requirement to establish and operate a hospital or other health facility;

WHEREAS, Executive Order No. 56, series of 2023, sign by the Hon. City Mayor Rozzano Rufino B. Biazon, dated December 28, 2023, **"Providing for the creation of the Technical Working Group (TWG) in consideration of the Establishment of a Women's Medical Center in the City of Muntinlupa, its composition and functions";**

WHEREAS, on July 23, 2024, the City Government of Muntinlupa held its ground breaking ceremony of the proposed **Women and Children's Health and Wellness Center located at Alabang, Muntinlupa City;**

WHEREAS, the Muntinlupa Women and Children's Health and Wellness Center is a health facility catering to the women and children constituents of the City funded by the Department of Public Works and Highways;
