

WHEREAS, Section 27of the Universal Health Care (UHC) Act or Republic Act (RA) No. 11223 states that, "The DOH shall institute a licensing and regulatory system for stand-alone health facilities, including those providing ambulatory and primary care services, and other modes of health service provision."

WHEREAS, the Department of Health (DOH) issued Administrative Order No. 2020 – 0047 or the Rules and Regulations Governing the Licensure of Primary Care Facilities in the Philippines, detailing among others the need for health facilities to secure a Permit to Construct as a requirement to establish and operate a hospital or other health facility;

WHEREAS, Executive Order No. 56, series of 2023, sign by the Hon. City Mayor Rozzano Rufino B. Biazon, dated December 28, 2023, "Providing for the creation of the Technical Working Group (TWG) in consideration of the Establishment of a Women's Medical Center in the City of Muntinlupa, its composition and functions";

WHEREAS, on July 23, 2024, the City Government of Muntinlupa held its ground breaking ceremony of the proposed Women and Children's Health and Wellness Center located at Alabang, Muntinlupa City;


