


**WHEREAS**, Section 16 of Republic Act 7160, otherwise kn as the Local Government Code of 1991, states that, **"every Local Government Unit shall exercise the powers expressly granted, those necessary implied therefrom, as well as povvers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare"**;

**WHEREAS**, Article 86 (bXI)(vi) and Article BO (b)(IXviii) of the Local Government Code of 1991 , provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

**WHEREAS**, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned"**.

**WHEREAS**, the City Government realizes the need of each barangay for additional ambulances to serve the growing needs of their constituents;

**WHEREAS**, the City Government of Muntinlupa shall enter into a Deed of Donation for the donation of nine (9) Hi-Ace Commuter ambulances to each nine (9) Barangays for their respective use;







**WHEREAS**, the Barangays need additional ambulances to enhance its programs on **health care, safety of their constituents** and to respond more effectively to emergency cases;

**WHEREAS**, to facilitate the delivery of basic services for the people of the city, the City Government of Muntinlupa through the **City Mayor Hon. Rozzano Rufino B. Biazon** is donating nine (9) Hi-Ace Commuter Ambulance with Basic Life Support to **nine (9)** Barangays;

**WHEREAS**, the City Government purchased nine (9) ambulances which shall be distributed as follows:



**WHEREAS**, the Committee Chairman requested the Muntinlupa City Disaster, Risk, Reduction and Management Office (MCDRRMO) to submit BAC Resolution as form part of this Deed of Donation and as proof that the purchase of the nine (9) ambulances with Basic Life Support (BLS) has passed the proper bidding process and the mandate of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** in behalf of the City Government of Muntinlupa to enter into and sign the **Deed of Donation** of nine (9) Hi-Ace Commuter Ambulances with Basic Life Support (BLS) to nine (9) Barangays in the City of Muntinlupa for their use and custody.

**RESOLVED, FURTHER**, to provide copies of this Resolution to the Chairmen of the nine (9) barangays and to all other offices concerned for their information and guidance
