No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;


WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-|RR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, on 7 August 2023 the Sanggunian, through Resolution No. 2023-305, authorized the Local Chief Executive to contract with BP Integrated Technologies, Inc., for Muntinlupa City's web display, cloudconn and mobile application being used by the Department of Disaster Resilience and Management (DDRM) for local weather monitoring;

WHEREAS, the previous contract with BP Integrated expired and there is to a need to renew the same for the period July 1, 2024 up to December 31, 2024;

WHEREAS, the end user, DDRM, expressed satisfaction with the services of the BP Integrated as the system offered real time monitoring of the state of weather and environment essential for effective decision and policy making of the said organization;


WHEREAS, the renewal of contract with BP Integrated is allowed under the Procurement Law (Republic Act 9184) under the Negotiated Alternate Mode of Procurement and the City Legal Office rendered a favorable endorsement of the same;

NOW, THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize a resolution authorizing the *City Mayor Hon. Rozzano Rufino B. Biazon*, in behalf of the City Government of Muntinlupa (CGM) to enter into and sign the renewal of Contract of Service (COS) with *BP Integrated Technologies, Inc.,* represented by *Arnel Bautista, General Manager,* on the provision of Annual Data Hosting services for the City Government of Muntinlupa's Web display, cloudconn and mobile application amounting to Three Hundred Twenty-Nine Thousand Three Hundred Twenty-Three and 26/100 (Php329,323.26) to be taken from the 2024 Executive Budget under the *Department of Disaster Resilience and Management (DDRM)*

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 16th day of September, 2024, on its 113th Regular Session.
