INVITATION TO BID FOR THE CONSTRUCTION OF MUNTINLUPA MEGA HEALTH CENTER (EARTHWORKS, FOUNDATION WORKS, STRUCTURAL STEEL COLUMNS FROM FOOTING LEVEL TO ROOF LEVEL & 2F FRAMING), ILAYA ST., BRGY. ALABANG, MUNTINLUPA

1. The City Government of Muntinlupa, through the duly approved **2024 Executive Budget & DOH Fund** intends to apply the sum of **Twenty Three Million Nine Hundred Nine Thousand Four Hundred Ninety Eight Pesos & 86/100 (P23,909,498.86)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Muntinlupa Mega Health Center (Earthworks, Foundation Works, Structural Steel Columns from Footing Level to Roof Level & 2F Framing), Ilaya St., Brgy. Alabang, Muntinlupa**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The City Government of Muntinlupa now invites bids for the above Procurement Project. Completion of the Works is required within **Two Hundred Ten (210) calendar days from receipt of the Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below from **7:00 o'clock am to 4:00 o'clock pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **December 4, 2024** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos (P25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile or through electronic means.
6. The City Government of Muntinlupa will hold a Pre-Bid Conference on **December 11, 2024** 8:30 a.m. at the Audio Visual Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **December 23, 2024** 8:00 a.m. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **December 23, 2024**, 9:00 a.m. at the Audio Visual Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The City Government of Muntinlupa reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
