## Contract Agreement

DEC 1 6 2024 20 between CITY GOVERNMENT THIS AGREEMENT made the OF MUNTINLUPA of the Philippines (hereinafter called "the Entity") of the one part and JADOMINIA CONSTRUCTION & SUPPLIES with address at San Antonio, Biñan (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Materials for Temporary Footbridges and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Three Million Two Hundred Ninety Five Thousand Nine Hundred Sixty Pesos (P3,295,960.00)(hereinafter called "the Contract Price").

# NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively 1. assigned to them in the Conditions of Contract referred to.

In consideration for the sum of Three Million Two Hundred Ninety Five Thousand Nine Hundred Sixty Pesos (P3,295,960.00) or such other sums as may be ascertained, JADOMINIA CONSTRUCTION & SUPPLIES agrees to the Supply & Delivery of Materials for Temporary Footbridges in accordance with his/her/its Bid.
- 4. The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
