WHEREAS, the Entity is desirous that the Contractor execute Completion of CHO Storage Facility: Architectural, Plumbing, Mechanical, Electrical Works & Landscaping at Pacwood Brgy. Tunasan, Muntinlupa/11387484 (hereinafter called "the Works") and the Entity has accepted the Bid for Twenty Four Million Nine Hundred Fifty Nine Thousand Four Hundred Forty Pesos (P24,959,440.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e.
