### Contract Agreement

WHEREAS, the Entity is desirous that the Contractor execute Construction of SPED Bldg., Accessibility Features, Architectural Finishes, Electrical, Mechanical, Fire Protection & Auxiliary Systems at Brgy. Poblacion, Muntinlupa/11370054 (hereinafter called "the Works") and the Entity has accepted the Bid for Fifty Nine Million Six Hundred Seventy Three Thousand One Hundred Four Pesos & 60/100 (P59,673,104.60) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
