





**WHEREAS,** Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "*The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx,as* " one of the corporate powers of the city as provided in Rule IX and shall:

*(i)"Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay*

**WHEREAS,** on November 4, 2024 the Sangguniang Barangay of Alabang enacted Ordinance No. 24-004 Series of 2024 authorizing the use of Supplemental Budget amounting to *Eight Million Two Hundred Seven Thousand Five Hundred Ninety-Seven Pesos and 97/100 (Php8,207,597.97).*;

**WHEREAS,** through Resolution No. 065-2024 Series of 2024, adopted on **October 28, 2024** the Sangguniang Barangay of Alabang adopted Supplemental Annual Investment Program (AIP) to support the Supplemental Appropriation;

**WHEREAS,** the City Budget office on December 02, 2024 endorsed to the Sangguniang Panlungsod and recommended to the latter that the Supplemental Budget of Alabang amounting to *Eight Million Two Hundred Seven Thousand Five Hundred Ninety-Seven Pesos and 97/100 (Php8,207,597.97),* be declared operative in its entirety;






**WHEREAS**, the Supplemental Budget is allocated as follows:


