WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, **"The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx,as "** one of the corporate powers of the city as provided in Rule IX and shall:

(i)"Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay

WHEREAS, on October 09, 2024 the Sangguniang Barangay of Ayala-Alabang enacted Ordinance No. 10-02 Series of 2024 authorizing the use of Supplemental Budget amounting to ***Eighteen Million Seven Hundred Ninety-One Thousand One Hundred Sixty Pesos And 79/100 (Php18,791,160.79);***

WHEREAS, through Resolution No. 10-02 Series of 2024, adopted on **September 25, 2024** the Sangguniang Barangay of **Ayala-Alabang** adopted Supplemental Annual Investment Program (AIP) to support the Supplemental Appropriation;

WHEREAS, the City Budget office on November 25, 2024 endorsed to the Sangguniang Panlungsod and recommended to the latter that the Supplemental Budget of **Barangay Ayala-Alabang** amounting to ***Eighteen Million Seven Hundred Ninety-One Thousand One Hundred Sixty Pesos And 79/100 (Php18,791,160.79),*** be declared operative in its entirety;




WHEREAS, the Supplemental Budget is allocated as follows:



ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 16th day of **December, 2024**, on its 126th Regular Session.


