**WHEREAS**, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

**WHEREAS**, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

**WHEREAS**, on **December 8, 2024** four (4) structures housing fourteen (14) families, were gutted by fire at **T. Molina St., Purok 5, Barangay Alabang, Muntinlupa City**;

**WHEREAS**, in a report rendered by the **Social Services Department** on **December 9, 2024** and received by the **SP Secretariat Office** on **December 10, 2024** the following were noted as casualties of the said fire:

1. **Four (4) structures;**
2. **Fourteen (14) families;**
3. **Fifty Three (53) individuals with the following details:**
  - a. **Eight (8) Children**
  - b. **Four (4) Senior Citizens**

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Ninety Thousand Pesos (Php90,000.00)** of Financial Assistance to the **fourteen (14)** families affected by fire on **December 8, 2024**, located at **T. Molina St., Purok 5, Barangay Alabang Muntinlupa City**.


